Take a closer look at the ARPC effect in 2024!

What a year! We've added new programs, doubled in staff, and begun exploring new revenue sources! With a staff of 23 people spanning nine programs, ARPC services a Region that covers over 6,700 square miles, home to nearly half a million people. So we stay pretty busy around here!

During the 2023 - 2024 fiscal year, ARPC staff utilized just over \$87,000 in member dues to generate a return of more than \$6.5 million in additional funding. This resulted in a Regional ROI of \$73 to \$1!

From overseeing the largest living shoreline in the state, to developing an online planning platform for healthcare agencies statewide, our staffs' collective expertise continues to have a lasting impact throughout the Region and beyond.




WELCOME TO THE TEAM!

ARPC ELECTS 2025 OFFICERS!

Congratulations to our 2025 Officers! Commissioner Ricky Jones has been re-elected as Chair, Commissioner Quincee Messersmith will serve as Vice Chair, and Commissioner Porter has retained the position of Secretary/Treasurer. In addition, Greg Slay of the Capital Region Transportation Planning Agency has been elected as an Ex-Officio Member. Congratulations again, and we are thrilled to work with you all towards the betterment of the Apalachee Region.



GRANTS AWARDED!

USDOT SAFE STREETS FOR ALL: ARPC Economic Development staff partnered with ARPC Transportation staff to apply for multi-year project funding to create a Regional Safety Action Plan that would complement work currently underway for the Rural Regional Transportation Plan (RRTP). ARPC was awarded 2-year federal funding in the amount of \$497,839. Project activities will kick off as soon as the contract is in place!

U.S. Economic Development Administration (EDA) Disaster Recovery Coordination Grant: ARPC staff applied for and received a 5-year federal funding award for \$500,000 to conduct disaster resiliency work in the Region. A variety of activities will be conducted under this funding, including an overhaul of the Apalachee Online website.

Florida Department of Transportation (FDOT) Beautification Grant: ARPC staff partnered with the Town of Sneads on an application for the 2024 FDOT Beautification Grant to create landscaping improvements along Highway 90. FDOT has awarded \$110,281 to the Town of Sneads to carry out this project.
